## Overview

ABB, a major player in the global solar inverter market, is paying \$470 million to unload the business to Italian company Fimer — an acknowledgement of ongoing challenges in a market driven by fierce competition and increasing price pressure. GE has entered into an agreement for FIMER to acquire ABB's solar inverter business. The transaction will enhance the future prospects of the solar inverter business and will include manufacturing and R&D sites located in Italy, India and Finland. GE is likely to divest its electricity conversion commercial enterprise due to low-income margins in that sector.

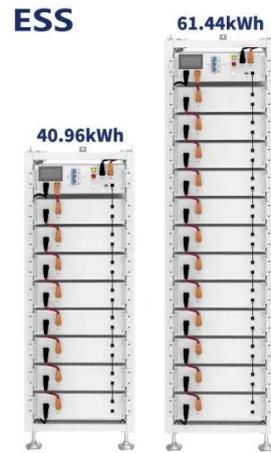
