

# Is it legal to build photovoltaic panels in rural areas



## Overview

---

While the federal government is involved in the siting of natural gas, hydroelectric plants, and certain transmission infrastructure, it has no authority whatsoever over the siting of solar arrays on private land. “Our prime farmland should not be wasted and replaced with green new deal subsidized solar panels. 




