Overview

Local zoning ordinances are emerging as a nationwide barrier to siting and building renewable energy projects. Counties, cities, or towns in all 50 states have imposed restrictions on renewables at the local ordinance level. Most states have solar access laws that forbid any agreement, covenant, condition, bylaw, or contract that outlaws or limits solar installations by Homeowners Associations (HOA) or other municipal bodies. Local restrictions have been applied to distributed and to utility-scale. From California's groundbreaking solar mandate to Florida's net metering policies, each state maintains distinct rules that directly impact installation costs, energy savings, and property rights.

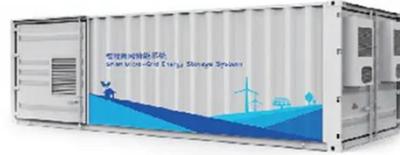
