Overview

Categorical exclusions (CatExs)—for actions or types of actions which individually and cumulatively are deemed to have minimal or no impacts on the environment. The actions may therefore qualify as excluded from detailed environmental analysis. Wind energy projects raise local land use, environmental, and community concerns similar to those raised by other commercial and impacts in the wind energy. Description of the Proposed Action: Bonneville Power Administration (BPA) proposes to upgrade communication facilities at Condon Wind Substation (owned by SeaWest Windpower, Inc.), Wasco Radio Station, and De Moss Substation. Currently, CCS has completed the preparation of 6 codes and standards and is preparing 4 codes for offshore wind power farm facilities. If a Federal Government antenna structure is to be used by a Commission licensee, the structure must be registered. 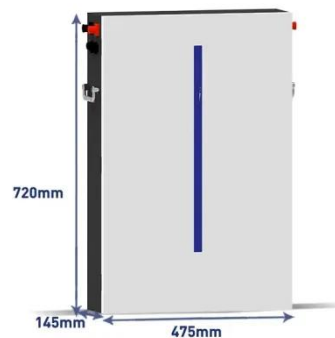
